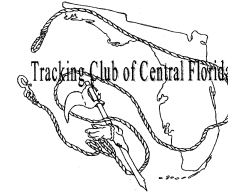

Entries must be on official AKC entry forms or photocopy of same including the reverse side with agreements and rules. Entry form must be signed.

EXCHANGE POLICY: The exchange policy will be in effect with the available tracks being filled first with untitled dogs, followed by titled dogs. If the limit for entries is not reached in the VST and exceeds the limit of the TDU, the number of tracks may be exchanged up to the day of plotting.

WORKER OPTION: There will be a separate draw conducted for the AKC Worker Option. Based on the number of VST and TDU tracks offered at this test, there will be 1 track available for each VST and TDU. Immediately after the Worker Option draw, any remaining test worker entries will be added to the non-worker entries for the draw of the remaining tracks. When the limit of entries has been reached, all remaining entries will comprise the Alternate list. Alternates have the option to accept, or decline being placed on the alternate list. Those that decline will have their entry fee and certifications, if applicable, returned. The Test Secretary will notify all entries of the draw by mail, e-mail or phone.

DRAW FOR VST TRACKS: The draw for running order of tracks will be held on Sunday, October 11, 2026 at 7:00 AM in the back parking lot of the Denny's Restaurant on State Road 436. The first track will be run following the draw about 7:30 AM. In the event an accepted entry is absent, the first attending alternate by the drawing will participate, and so on.

DRAW FOR TDU TRACKS: The draw for running order of tracks will be at 7:00 AM at the same location.

ELIGIBILITY FOR VST TEST: The Variable Surface Tracking test (VST) is for dogs that have earned the TD, TDU or TDX title. A dog may continue to participate in this test after it has earned the VST title. However, dogs not holding a VST title shall be given preference for entry in the test by the Tracking Test Secretary.

ELIGIBILITY FOR TDU TEST: The Tracking Dog Urban test shall be for non-TDU titled dogs and dogs that have earned the TD, TDX, VST, or TDU Title. A dog may continue to participate in this test after it has earned the title TDU. However, the Tracking Test Secretary shall give dogs not holding any of the above titles priority for entry in the test. With the entry of a non-TD/TDU titled dog, there must be included an original statement (certification) dated not more than one year prior to the test date, signed by an AKC Tracking Judge, stating that the dog is considered to be ready for the Tracking Dog Urban Test.

BITCHES IN SEASON MAY PARTICIPATE:

Entrants must notify the Test Secretary and judges that their bitch is in season prior to the drawing for tracks. Bitches in season will participate only after all other dogs have been tested.

AWARDS:

Those handlers and dogs marked "Passed" by the judges will be issued a certificate by the AKC.

CONDITIONS AT THE TEST SITE:

Lee Vista is an office/industrial park.

****ATTENTION EXHIBITORS and SPECTATORS****

Due to the change in nature of the fields being used by clubs for tracking tests and the increased population at these sites by the general public, dogs shall be "on lead" at all times on any areas of the tracking site. A dog that is allowed to run free and off lead, at any time before the test, during the test, after failing or after the completion of its' track, shall be failed and excused. If this occurs before the test, the dog shall be excused and not allowed to run in the test.
